Subject: Registration and Submission of NHDP Proposals through the New MIS Portal for FY 2025-26-Reg.

The Office of Development Commissioner (Handicrafts) implements programs for the development of the handicraft sector and the welfare of artisans under the NHDP & CHCDS schemes. A new MIS portal (<https://indian.handicrafts.gov.in/en>) has been developed to invite online application, processing, and monitoring of programs under the schemes, providing better accessibility and support to all stakeholders.

Key features of the New MIS portal:

- Provides centralised access for artisan-related information, benefiting artisans, entrepreneurs, exporters, & other stakeholders.
- Adhaar-linked data for artisans to improve monitoring and enable end-to-end digitization of DBT schemes.
- Helps stakeholders from proposal application & processing to reimbursement settlement.
- Supports effective scheme monitoring and provides various online information retrieval options.
- Integration with the existing MIS and NGO Portal.

For FY 2025-26, all NHDP programme proposals must be submitted through the new MIS portal. Stakeholders are urged to register on the portal as early as possible. Two nodal officers (list enclosed) from each regional office will coordinate the exercise for better implementation.
